

Terms & Conditions

It is expected that Members use common sense, fly safely and take all reasonable precautions to avoid causing damage to other persons or property. Members agree that they have read and will abide by the following terms and conditions:

- All model aircraft are to be operated in accordance with the Drone Code and CAA Regulations & Guidance.
- Member Pilot to comply with the Drone & Model Aircraft Registration & Education Scheme (DMARES) and supply DCC with details of their CAA Flyer ID.
- Line of Sight Flying only; Model aircraft to remain in sight at all times and not to be flown higher than 400ft.
- Model aircraft to be kept away from aircraft, helicopters, controlled airspace, airports, aerodromes, HIRTA's and danger, prohibited & restricted areas.
- Model aircraft must maintain relevant minimum distances from uninvolved people, vehicles, buildings, structures, animals and congested areas or large gatherings according to the class of drone and qualification held by the pilot, as per CAA Regulations.
- Excludes Drones and Remote Controlled Model Aircraft larger than 7kg in weight.
- Model aircraft piloted by a 3rd party, or flown commercially, are not covered for any losses, howsoever arising.
